

LESSON NINE

PROPERTY CLEARING

We are attracted to properties that are vibrationally aligned to us. It's not uncommon that, after a Soul Realignment® session has been done, a client becomes vibrationally misaligned to their property - they've changed, but their property has not! This will change over time, but sometimes clients become quite sensitive to their environment, especially if it is shared with other family members.

Properties are very simple to clear! There is no need to go into detail on a story behind negative influences on properties. We just need to uncover what influences exist, and then we can proceed to the clearing work.

You can perform energetic realignment on properties, which can be considered



energetic “entities” of sorts. You can clear any property that you energetically “own,” meaning that your free will governs the property. You can also do so on behalf of your clients.

Energetic “ownership” of property follows financial responsibility. If you are paying rent on an apartment, you energetically “own” that apartment. However, you do not energetically “own” any part of the building other than the apartment, so you cannot do clearing work on common areas. We cannot clear public property, because our free will does not govern the property!

We cannot clear our place of work because we actually do not energetically “own” our workplace, since we don’t pay rent there. The exception, of course, is if you actually rent out your workspace.

There is no need to be physically present to clear a property. All you need to “look up” a property in the Akashic Records is the property address. You access the Records as you normally would, but instead of locating a specific Soul, you simply locate the property!

LOCATING THE PROPERTY

There is never an issue with locating a property in the Akashic Records. Unless the person that is requesting this work is not the “energetic owner” of the property, you’ll always receive a “yes” answer to whether you have the property located. A property has no free will of its own, so it cannot refuse clearing work!

PORTALWAYS

Portalways located in and on properties are still energetic doorways, but unlike portalways in readings for Souls, they are not appropriate. They allow Earthbound Souls to come and go. Portalways on properties make us uneasy!

Portalways are usually in the corners we tend to avoid, the mirrors that make us feel uneasy, and the closets we never use. Children and pets may also avoid these spaces in our homes.

Portalways on properties may cycle open and closed periodically, depending on the activities and the energy in the home. We simply want to find out how many there are, and the clearing work will close them for now.

INDEPENDENT NEGATIVE THOUGHT FORMS

Any Independent Negative Thought Forms attached to a property don't run programs, but may create a vague discordant energetic quality within the home that affect the people living there.

They are initially attracted to homes because a "like" negative energy has been created by the inhabitants of the home. Often, a series of inhabitants are drawn to a home that continue to uphold this negativity - like attracts like! You can use your programs / energetic statements chart to uncover what energetic qualities these Independent Negative Thought Forms contribute to the property.

EARTHBOUND SOULS

Earthbound Souls, Independent Earthbound Souls, and Disruptive Earthbound Souls may also be attached to a property. Occasionally, Independent Earthbound Souls remain attached to a property because it is the place of their last transition, and while their family members may no longer be there, they learned to draw energy from the environment. Disruptive Earthbound Souls are more commonly found attached to property than people, although they are not generally common.

The more Earthbound Souls are attached to a property, the more uncomfortable we feel in it! Earthbound Souls within a property always lead to a low level generalized energy of confusion, frustration, anxiety, sadness, or stuck-ness. Remember, these Souls are stuck within the physical plane and don't really understand their current situation. Earthbound Souls in a property should never be tolerated! Disruptive Earthbound Souls always lead to drama, upheaval, and disorganization within the property.

NEGATIVE THOUGHT FORMS

Just like with people, negative thought forms can be upheld within a property - by a whole family, or a group of co-workers or employees. Similarly, negative thought forms can also be created about or directed at a property - sometimes our neighbors may have formed very distinct opinions about us! These thought forms can have a mild effect on those inhabiting the property. Negative thought forms created about or directed at a business by a competitor, such as a small storefront or restaurant, can also negatively affect business.

ANGER SPEARS

Anger spears can also be directed at a property. Sometimes we may anger a neighbor! If the property is a workplace or business, former employees, competitors, or partners may be holding a lot of anger towards the business, their former employer, or their co-workers. This will affect the property, because that is the main identification of the business! Remember, we can only clear a business property on behalf of the business owner who owns or leases the space.

GATEWAYS

If portalways are energetic doorways, gateways are energetic highways!! They are extremely disruptive and create a lot of discordant energy because a lot of Independent Negative Thought Forms will use them to come and go. Gateways can cause us to lose sleep, to get very grumpy and disgruntled, unfocused, or lethargic. They draw a lot of energy from the inhabitants of the home, often making it hard for them to manifest what they want. Gateways are often “turn-offs” for prospective home buyers. They make us feel very uncomfortable. Gateways are relatively rare in our clients’ homes.

LAND ASSIGNMENT

The Earth is much older than we are and much has happened on the land that we currently inhabit! From time to time, land is consecrated or energetically assigned to a specific use.

This land assignment is upheld by the Earth on which the property is located until it is released and can be at odds with with the energy of a home or workplace.

A sacred site can make us feel like trespassers in our own homes. We feel that we should not be there. Clients will simply not feel comfortable. Building on a sacred site can also be uncharacteristically problematic - permits may be delayed, etc.

A battle ground means the obvious - battles were once fought on the land! The land will hold the energies of upheaval, desperation, aggression, and sadness. There may be conflict with neighbors. There may also be a large number of Earthbound Souls attached to the property.

A burial ground can also lead to a large number of Earthbound Souls within a property. This can lead to a lot of anxiety, unrest, discomfort, frustration, and stuck-ness to the overall energy of the home.

- *Was this land ever assigned as a sacred site? A battleground? A burial ground?*
